Belize, the only English speaking country in Central America is a beautiful jewel bordered by the Caribbean Sea, Guatemala and Mexico and is less than 2,500 miles and 5 hours flying time away from the City of Los Angeles, California.

Under the Consortium for Belizean Development, Inc., a 501(c)3 non-profit organization, the *Elegant Flair Dance Tour 2006* has taken shape and is poised for success. A 10-day tour is scheduled for July 13 – 23, 2006. 
